

SURVEYS! (Full results to come)

Anyone who would still like to take our survey should look for us randomly on the beach. We now have approximately 1,200 completed (and collecting) surveys done between July 31 and August 31 to make them statistically significant. These are the results from #'s 1000-1100 randomly administered surveys (with many thanks to our survey distributors, especially to Danno (Croc), Loretta, and the Ice Cream Bear) for just question number 8 which asks: "When visiting WB, do you use the beach nude (49%); Use the beach wearing clothes (29%); Some mix of clothing and/or nudity, depending on the weather or other considerations (22%), Other (0), Don't know/refused (0).. We have a volunteer cartographer who will be mapping the postal and zip codes of those who included them. Data entering is a daunting but not impossible task but then we will have all results cross tabulated and will publish them. No one can ever capture in statistics the mystique of Wreck Beach but perhaps we can all gain a better understanding of one another, textile and naturist. And, one fact

is blindingly clear from all the surveys and that is that we are all united in our love of this magical place where land meets river and sea!

TO: Naturists and other concerned citizens everywhere in both the US and Canada! Dear Fellow American and Canadian Naturists: Together with the local naturists of Save Lighthouse Beach, the Naturist Action Committee is asking for your immediate action on an important matter concerning Fire Island National Seashore. With permission and by request, this NAC Action Alert follows (and is largely taken from) a similar alert released by Save Lighthouse

Beach.

NAC asks that you email and/or fax a letter immediately to the National Park Service, requesting that consideration of clothing-optional recreation be included in the General Management Plan, as that plan moves toward completion. Details follow. BRIEF BACKGROUND

Each National Park Service unit has a General Management Plan (GMP) that guides the actions of unit managers. Those plans are updated from time to time, however, the GMP for Fire Island National Seashore (FINS) has not been updated for 30 years. The process of revising and updating the FINS GMP began in 2007 and is presently approaching its final stages. The new GMP is expected to affect Fire Island National Seashore the 15 20 next to years.

For decades, clothing-optional recreation has been a popular choice among visitors to Fire Island National Seashore. Park Service managers have largely managed FOR clothing-optional use, despite the lack of guidance from the existing GMP. You have a chance to be heard on issues that will guide the next two decades. SUBMITTING COMMENTS FOR DEADLINE You MUST act quickly. The comment period for the Island National Seashore General Management Plan ends Sept. 6 11:59 PM. WHAT NAC ASKING YOU TO DO? The Naturist Action Committee is asking you to do ONE thing: just

1) Immediately send your comments by e-mail, fax or surface mail, supporting clothing-optional recreation as an important part of ANY plan for Fire Island National Seashore. Send your e-mails to the National Park Service at the addresses listed below. WHO SHOULD WRITE?

WHAT TO SAY? There are four management alternatives being considered. None of the four plans directly addresses clothing-optional use on beaches where it is currently accepted. It is important that each of the alternatives under consideration retains the traditional clothing-optional use of these areas. Here are some suggested points you may wish to make:

- 1. Identify yourself. Anonymous correspondence is often disregarded. If you are a past or prospective visitor to Fire Island National Seashore, please say SO prominently. Be brief and polite.
- 3. You should STATE VERY CLEARLY that you wish clothing-optional recreation to be included in plans for the Seashore, REGARDLESS OF WHICH MANAGEMENT OPTION IS ULTIMATELY CHOSEN.
- 4. Point out that skinny-dipping and nude sunbathing are valid recreational choices. In 2006, the Naturist Education Foundation commissioned the independent Roper polling organization to survey Americans on the topic of clothing-optional recreation. Seventy-four percent of Americans believe that those who enjoy nude sunbathing should be able to do so at a place set aside for

purpose. that

5. You may mention that in that same survey, a clear majority (54%) of Americans believe that government agencies should set aside public land specifically for clothing-optional recreation.

6. You may mention that traditional clothingoptional areas, like Lighthouse Beach within Fire Island National Seashore, contribute to the Parks. National diversity of our

7. Use your own experiences to personalize your comments. This is not the place for complaints. Skinny-dippers and nude sunbathers simply wish to be included in the General Management Plan. 


